COURSE OBJECTIVES:

- 1. To understand the logics of research design and procedures of conducting research
- 2. To grasp the basic skills and strategies of qualitative research methods.
- 3. To know how to raise research questions and select appropriate research methods in accordance to the questions at hands.
- 4. How to collect, analyze, and interpret data.

Classes will utilize a variety of formats: lecture, video, large and small group discussions, and student presentations.
